

FROM THE PRESIDENT

#### Time for a Rethink:

#### WA Fishers and Boaters Leading the Way for Healthy Demersal Fisheries

There has been a lot of concern for demersal fish recently following the release of stock assessments highlighting sustainability issues for demersal stocks around the state.

While many people have told me they are still catching plenty of snapper the science is saying there are issues that need to be addressed. The Minister is set to make an announcement on the future management of demersal fish in the next few weeks.

With the current uncertainty about what the rules, bag limits or seasons will look like many anglers are asking the same question: How do we still enjoy our fishing while helping protect the future of these prized species?

Western Australian boaters and fishers have a proud record of caring for our oceans and doing the right thing when it comes to looking after our fish. WA boaters are already showing what responsible fishing looks like. Clubs have shifted from a "Catch and keep" mindset to one built around the simple principle of doing the right thing. Some ot the initiatives clubs have done include:

- adopting mystery-weight prizes instead of "biggest fish" categories, reducing pressure to upgrade catches.
- promoting catch, photo and release competitions rather than bring a fish back simply to be weighed.
- encouraging boaters to explore alternate target species such as pelagics around Fish Aggregating Devices (FADs), helping spread fishing effort while keeping the excitement alive.
- celebrating good catch care practices such as using release weights, handling fish gently with wet hands, requiring soft or knotless nets, using circle hooks to reduce deep hooking and reviving fish before release,
- · ensuring fish weighed in at competitions are presented on ice in edible condition
- double point for witnessed successful releases, extra points for non-demersal species and
- limits on how many demersal fish can be weighed in.
- promoting the fisheries Send us your skeleton program to assist research,

It is clear WA's boaters are already changing the way they think about and value demersal fish. Across the State, boaters, fishers and local clubs have been quietly getting on with the job. In addition, WA boaters have also been busy restoring habitat, supporting research, and helping fish stocks recover.

From Exmouth to Esperance, boaters have led the way building artificial reefs, reseeding seagrass meadows, and protecting spawning fish. Artificial reefs have created new marine life hotspots from Esperance to Exmouth boosting biodiversity and easing pressure on natural reefs. Seagrass restoration projects in Cockburn Sound and shark bay are helping bring back critical nursery habitat. Stocking programs like Snapper Guardians which sees kids releasing baby snapper is building great stewardship and appreciation of our oceans.

Every one of these initiatives has been driven by local boating communities with a shared belief that good fishing starts with healthy oceans and active stewardship. Our boating community once again needs to step up to protect demersal fish.

Demersal fish hold enormous social value in Western Australia. They are part of our culture, our coastal lifestyle, and our connection to the sea. A day on the water chasing a dhufish or pink snapper is a cherished tradition for hundreds of thousands of West Aussies, it's about family, friendship, and time spent together.

At the same time, it is important to acknowledge commercial fishing for demersal fish plays an important role in suppling fish to those who don't have a boat so there needs to be a balance between commercial and recreational fishing. The productive waters and smaller populations in WA's north are perfect for ensuring our super markets have demersal fish for the community while the West Coast where most of WA's boaters and

recreational fishers live demersal fish are far more valuable as a recreational resource delivering wellbeing, regional tourism, and social connection.

At times like now when there is less fish available to catch it makes sense to ensure every fish that is caught delivers the greatest overall community benefit. That's good fisheries management: getting the best community value out of every fish while ensuring healthy stocks for the future.

The strength of WA's boating community lies in our willingness to roll up our sleeves and be part of the solution. Fishers, boaters, clubs, researchers, and local businesses have shown what's possible. From changing the way competitions are run, celebrating good when we work together building reefs, reseeding seagrass, supporting research through fish frame donations, and backing better science to guide management. It's this community spirit that will keep our fisheries healthy and our coastal lifestyle thriving.

I have embraced the sport fishing principle of doing the right thing for many years, and have been able to pass along much of that knowledge to the next generation of family and friends. Now the Grandchildren are here and hugely keen to be on a boat and catch a fish and I very much wish to share that experience and knowledge with them. I will show them the joys of fishing and instill in them the need to fish for the future.

Healthy fish, healthy habitats and healthy communities, That's the future we're all working for. With a lot of luck and some good management my grandkids will be able to take their grandchildren out fishing for demersal of the WA coast.

#### Fishing Futures Forum to protect WA's demersal fish

Key stakeholders from across the fishing community have come together to take part in the Fishing Futures Forum and play their part in ensuring there are Western Australian demersal fish for the future.

Cook Government leads critical science and management forum to protect 'at risk' demersal fish stocks for the future

Scientific stock assessments, reviewed by an international expert, show key WA demersal species are under severe threat

Long-term fisheries management solutions needed to rebuild fish stocks

Key stakeholders from across the fishing community have come together to take part in the Fishing Futures Forum and play their part in ensuring there are Western Australian demersal fish for the future.

The latest scientific stock assessments for WA's demersal species show depleted stock levels along much of the State's coastline, prompting urgent action to enable stocks to recover.

The Cook Government has called on representatives from the recreational, commercial, and charter fishing sectors, scientists, small businesses, and the wider community to be part of the solution.

The forum aims to co-develop guiding principles to inform government decisions and generate practical, forward-thinking ideas that support long-term sustainability.

Participants will include peak bodies representing WA's commercial sector, recreational fishers, and charter tourism, the Western Australian Fishing Industry Council, Recfishwest, and Marine Tourism WA.

They will be joined by representatives from fishing and boat clubs, seafood businesses and tackle shops, the Aboriginal Fishing Advisory Committee, WA universities, and marine conservation organisations.

The forum will be led by independent facilitator Susanna Durston, while Fisheries Research and Development Corporation managing director Sean Sloan, South Australian Research and Development Institute research scientist Dr Troy Rogers, and Australian Fisheries Management Authority senior manager Dan Corrie will provide insights from State and Commonwealth fisheries.

Participants will have the opportunity to have their say and share their ideas on the future management of WA's demersal fisheries throughout the forum.

The government will consider the outcomes of the forum to help guide management decisions that need to be made by the end of the year.

The stock assessments for WA's demersal species have been independently reviewed by international expert and CSIRO scientist Professor André E. Punt.

Comments attributed to Fisheries Minister Jackie Jarvis:

"We know that several demersal species State-wide are under serious threat from continued fishing pressure, including pink snapper, red emperor, and dhufish - which is only found in WA.

"Our fisheries make a significant contribution to the WA economy and lifestyle, and we want to ensure our kids and grandkids can enjoy the same fishing opportunities as we can today.

"Today is an important step in protecting the long-term sustainability of our demersal fish.

"I want to thank everyone for coming together to be part of the solution and understanding the need to work together to protect this shared resource.

"I've been very clear, that we need all management options on the table and I urge everyone who cares about our demersal fish to have their say so we have fish for the future."

4.2.2 Zooplankton in Cockburn Sound

Westport has partnered with the Western Australian Marine Science Institution (WAMSI) to deliver the \$13.5 million WAMSI-Westport Marine Science Program. This 3-year program is developing the latest data, information and modelling on the complex environmental systems and community values associated with Cockburn Sound.

Project 4.2.2.2 Zooplankton in Cockburn Sound

Theme: Fisheries and Aquatic Resources

Researchers: Strzelecki, J. (2025)

Examining zooplankton abundance, biomass, and phytoplankton biomass in Cockburn Sound

This study examined zooplankton abundance, biomass and phytoplankton biomass in Cockburn Sound, assessing their spatial and temporal variability. The study was conducted at 15 sites over one year and found that zooplankton abundance and biomass were highly variable, with copepods (small planktonic crustaceans) dominating throughout. The findings highlight the importance of hydrodynamic retention, nutrient availability and biological interactions in shaping plankton communities.

How Westport will use the report

Westport will use this research to inform environmental ecosystem modelling and our environmental impact assessment.

#### Woodman Point – Western Boat Ramp Replacement

The Woodman Point Recreational Boating Precinct includes the busiest public boat launching facility south of Perth. There are eight lanes for boat launching with catwalk jetties, a floating universal access pontoon and parking facilities.

Four of the boat ramp lanes and two fixed catwalk jetties, located on the western side of the boating facility, are the oldest at the facility.

Two of the four lanes to be replaced were built in 1981 and an upgrade in 1985 saw two additional concrete ramps built.

Project background

To ensure continued safe launching facilities for the public at Woodman Point, four lanes and two catwalks will be replaced.

The oldest section of the ramp is now more than 44 years old and beyond its design life of 40 years. An inspection of the Western boat Ramp was conducted in December 2022 and the overall condition was classed as poor. Both the launch ramps and the fixed catwalk jetties are no longer fit for purpose, and don't meet the DTMI guidelines for this type of structure. They are in need of significant upgrades and both the boat ramp lanes, and the catwalk jetties will be replaced.



#### FREMANTLE SAILING CLUB ACHIEVES CLEAN MARINA & FISH FRIENDLY ACCREDITATION!

We are delighted to share some fantastic news: **Fremantle Sailing Club (FSC)** has successfully regained its **Clean Marina accreditation**, along with **Fish Friendly certification**. This achievement is a testament to our commitment to environmental responsibility and sustainable marina operations.

#### **About the Clean Marina & Fish Friendly Programs**

**Clean Marina** is an international, voluntary accreditation program for marinas, boatyards, and associated industry operators. The goal of the **Clean Marina and Fish Friendly** initiatives is to reduce non-point source

pollution, protect and enhance inland and coastal waterways, improve fish habitats, improve air quality, and support thriving, sustainable marina businesses.

#### Our journey to reaccreditation

As many of you know, FSC previously held Clean Marina accreditation but lost it in 2018 due to compliance challenges. Since then, reinstating this status has been a key goal for the Club. Regaining accreditation for a facility of our size and complexity is no small task, and we are incredibly proud of the team effort that made it possible. Accreditation involves meeting over 60 stringent criteria covering compliance, facility management, emergency preparedness, and boater education.

#### What changed?

Over the past months, we have implemented a series of improvements to meet the program's stringent criteria, including, but not limited to:

- Enhanced fuel safety: Upgraded signage on all fuel bowsers with clear emergency protocols and contact details. (Temporary signage is currently in place while permanent signage is being arranged.)
- **Improved waste management:** Installed a new wastewater treatment system and reviewed disposal practices for boatyard waste streams, including sandblasting grit.
- **Emergency readiness:** Added fire suppression equipment, spill kits, absorbent booms, and containment systems across key locations.
- **Safer storage:** Installed new flammable storage cupboards and bunding for large drums in contractor areas.
- **Infrastructure upgrades:** Added a new fire hydrant, installed new fire pumps throughout the site, and improved security systems with cameras in critical zones.

A commitment to our CommunityThis reaccreditation is more than a milestone it's a promise to our members and community that FSC will continue to lead in environmental stewardship, ensuring our operations safeguard the ocean for generations to come.

#### Pinky Beach Access Upgrade | November 2025

Pinky Beach

Commencing: 10 November 2025

Completion: 20 November 2025

A short section of the existing boardwalk will be removed to build a new accessible ramp and entry, along with bike parking and improved connections between the road, boardwalk, and paths.

There will be minor disruptions for service vehicles accessing Discovery Resorts - Rottnest Island.

The Pinky Beach access point will be closed during the works. An alternative access point located 50 m south will remain open, with signage in place to assist visitors.

#### Rottnest Island late-night ferry services to boost visitor economy

Rottnest Island will commence seasonal late-night ferry services to and from the island starting 30 October, enabling visitors to experience the island's growing dining scene.

- Seasonal late-night Rottnest Island ferry service commencing 30 October
- A 9pm service will depart Rottnest Island October to April
- Extended ferry schedule to activate evening island experiences
- Supports Cook Government's commitment to diversify the economy so it remains strongest in the nation

#### **Swan and Canning Riverparks**

#### Applecross Ferry Terminal, Applecross - Application under the Metropolitan Region Scheme

Update 24 October 2025 - Public comment on this development application closed on 23 October. Feedback from the community, key stakeholders and local government will be considered to inform a recommendation to the Western Australian Planning Commission (WAPC).

A WAPC meeting to determine the application will be scheduled when the assessment is complete and all registered parties will be informed of the meeting date.



#### Overview

A development application for a new ferry terminal in Applecross, City of Melville has been received by the Western Australian Planning Commission (WAPC). The application is to be determined under Part 10 of the Metropolitan Region Scheme (MRS).

The application forms part of the Public Transport Authority's METRONET on Swan Ferry Service Expansion Project(External link). Valued at \$7.7 million, the proposed ferry terminal comprises of the following land and water-based elements:

- a fixed jetty with covered waiting area
- gangway and floating pontoon
- modifications to the footpath and principal shared path
- bicycle u-rails, and
- landscaping adjacent to the land-based infrastructure.

The application from Element Advisory on behalf of the Public Transport Authority is being advertised to seek public comments.

A further \$1.85 million in State Government funding is now available to public land managers over the next two years as part of the Swan Canning Riverpark Urban Forest program.

Grants are available for projects up to three years that aim to expand urban canopy and enhance biodiversity, with the program contributing up to two-thirds of total project costs.

To date, the program has funded 20 projects, delivering 41 hectares of weed control, 27 hectares of revegetation and the planting of more than 500,000 native plants.

Applications close 4pm on Friday, 28 November 2025 with further opportunities opening in 2026.

#### **News from the South West**

#### Our South West team goes above and beyond to remember Marley



A much-loved dog who made Casuarina Boat Harbour at Bunbury his home for more than a decade has been honoured with the naming of a street at the Department's facility.

Following the passing of Marley, in acknowledgement of the significant loss felt by harbour users, our South West office sought approval from Landgate to rename Boat Ramp Road to Marley Place working in close collaboration with the City of Bunbury and the South West Development Commission.

In 2013, Marley first came to live at the harbour with his owner who had rescued him years earlier as an orphaned pup in the Pilbara. Marley became a familiar face at the harbour and was much loved by locals and visitors.

Marley's owner moved away from the harbour in 2022 but the adjustment was too much for Marley and he was returned to the harbour unofficially adopted by Marine Rescue Bunbury and the harbour community.

Also referred to as the harbour dingo because of his appearance, there was a huge community response when Marley died in June 2025.

The renaming of Boat Ramp Road to Marley Place was especially fitting as it leads to the headquarters of the rescue group who looked out for his welfare, providing food, fresh water and a place to shelter.

#### • Major funding boost for Bindjareb Djilba (Peel-Harvey estuary)

Grassroots efforts to restore the Bindjareb Djilba (the Peel-Harvey estuary) are getting a major boost, with the Cook Government investing \$5 million to back community-led projects and Traditional Owner partnerships, fulfilling an election commitment.

- Total of \$5 million allocated for community-led initiatives that restore rivers and increase care of waterways
- Bindjareb Traditional Owners to receive \$1.3 million to continue Aboriginal-led partnerships in waterways planning and management

 Peel Development Commission will receive \$3.7 million for river restoration and schools program supported by the State Government

Grassroots efforts to restore the Bindjareb Djilba (the Peel-Harvey estuary) are getting a major boost, with the Cook Government investing \$5 million to back community-led projects and Traditional Owner partnerships, fulfilling an election commitment.

The Peel Development Commission will receive \$3.7 million, with projects to be delivered through the Peel-Harvey Catchment Council targeting priority areas near the Waangaamaap Bilya (Serpentine River) and surrounding waterways.

The funding will accelerate on-ground action to protect the estuary's health and build climate resilience.

Activities that will be delivered include:

revegetating 142ha of land along the Waangaamaap Bilya;

- installing 10km of fencing to exclude livestock and pests;
- reintroducing habitat to support native fish, mussels and rakali;
- launching a tailored education program for primary schools in Mandurah and Dawesville; and
- supporting community groups involved in river and estuary restoration.

An additional \$1.3 million has been allocated to support Bindjareb Traditional Owners and strengthen ties with local Aboriginal corporations. This will help to drive Bindjareb-led actions under the Bindjareb Djilba Protection Plan (BDPP) and leadership in estuary and catchment management.

Key initiatives include:

- continuing the Bindjareb Djilba Kaadadjan Bidi Yarning Circle for collaborative governance;
- partnering with Winjan, Waroona and Harvey Aboriginal Corporations;
- enhancing a digital cultural mapping tool to embed cultural values in decision-making;
- delivering the Culture First Waterways Action Plan; and
- advancing projects that promote cultural health and economic opportunity.

The Department of Water and Environmental Regulation (DWER) is also working closely with Bindjareb people through cultural governance, and knowledge sharing via the Bindjareb Djilba Kaadadjan Bidi Yarning Circle and the BDPP Policy and Planning Committee.

The Bindjareb Djilba Protection Plan, launched in 2020, is a whole-of-government strategy to safeguard the estuary's ecological, cultural, social and economic values by improving water quality and climate resilience ensuring it continues to support the community, environment and local economy for generations to come.

#### Court full of Peel-Harvey fishing offences

Media release A 42-year-old Swan View man has been penalised \$3,174 this week (4/11) in Mandurah Court for taking 109 mullet over the daily bag limit.

Last updated: 6 November 2025

The man was observed by DPIRD Fisheries Officers in February removing fish from a set fishing net at Herron Point in the Peel Harvey Estuary and coming ashore with 58 mullet.

An inspection of the man's vehicle revealed a further 81 fresh mullet which he had admitted to netting.

The daily bag limit for mullet is 30 and set net fishing is only allowed in Peel Harvey waters from 4.30pm to midnight on Wednesday nights from 1 November until 31 July.

Also in Mandurah Court, a 28-year-old Byford man was ordered to pay \$2,844 for being in possession of 23 undersize blue swimmer crabs caught in estuary waters in January off the Coodanup foreshore.

The minimum width of the crab carapace needs to be 127 millimetres. In this catch, an inspection by Fisheries Officers recorded the carapace widths of the undersize crabs ranged from 76.4 mm to 121.4 mm.

All crabs in the man's possession, including one of legal size, were seized and released back into the water.

In a separate matter, a 42-year-old Northbridge man was and penalised \$2,244 for obstruction and possession of undersize crabs taken at the Rivergums Boat Ramp in South Yunderup in December 2024.

The man, who had been fishing from a jetty with crab drop nets, attempted to dispose of two undersize crabs to avoid them being measured by Fisheries Officers. A third crab in the man's possession was measured and found to be undersize.

Regional Compliance Metro Director Todd A'Vard said fishers should expect that DPIRD Fisheries Officers could be operating in the Peel region at any time throughout the year.

"Fishers must be aware of the rules prior to going fishing and ensure they don't fish beyond the bag and size limits which are there to protect the sustainability of these recreational fisheries for everyone to enjoy," he said.

The rules for recreational fishing are available in the <u>Recreational fishing guide 2025</u> and information can also be found online by searching the <u>rules by species and location</u>.

Anyone who suspects illegal fishing activity should call <u>FishWatch</u> on 1800 815 507 or report the matter via the online form on *Crimestoppers*.

# Dampier's STARDECK Mackerel 5000 once again stands out for scientific fish sampling

October 28, 2025

As expected, Dampier's STARDECK Mackerel 5000 has shone, producing a healthy number of Spanish mackerel samples being donated to science by local fishers.

The 2025 STARDECK Mackerel 5000 held in Dampier, organised by the Nickol Bay Sportsfishing Club, showcased the Pilbara as a powerhouse for this pelagic predator, with 56 Spanish mackerel – including the winning fish – sampled at the table.

Supported by Woodside Energy, the Recfishwest Fishing for Science team joined forces with DPIRD researcher Paul Lewis for the event, collecting important data for ongoing research to help inform the future Pilbara's Spanish mackerel stock assessment.

The idea of Fishing for Science is simple but powerful – anglers donate their catches at the weigh station, and our team records vital data and takes samples. This allows fishers to become better stewards of the fishery, aiming to give participants a better scientific understanding of important recreational species and how they can help improve their sustainability.

Backed by STARDECK, this year's competition saw 50 participating boats and over 150 anglers happy to donate fish. The data collected included biological information (length, weight, sex, and gonad stage) and otoliths (ear bones) which are used by Fisheries to determine the age of a fish by examining the annual growth rings (bands) under a microscope.

Since 2020, more than 500 pelagic fish have been sampled from recreational fishers participating in Pilbara recfishing events, directly contributing to monitoring the large pelagic resource in the North Coast Bioregion. <u>Find out more here.</u>

"The Mackerel 5000 always produces a lot of mackies each year and they are usually very healthy fish, so the competitors kindly making these contributions to science is always greatly appreciated," said Recfishwest's Senior Operations Officer Sam Russell.

"Along with collecting samples we're here to have a good yarn with the locals, the Nickol Bay Sportfishing Club, King Bay Game Fishing Club on how we can improve fishing in the Pilbara and they always make us feel welcome."

Big prizes for big macks

As always, the Mackerel 5000 lived up to its reputation for producing some of the biggest Spanish mackerel catches out of any WA-based competition.

The top honors for biggest mackie went to Art Skotniczny, who almost cracked the magical 30kg mark with a monster 29.60kg mackerel, earning him the grand prize of \$5,000 sponsored by the Stardeck Group.

Even the youngsters got in on some prizes that would make any avid fisher jealous, with Michael Clauson (pictured below) taking out the Junior Overall category with a 15.06 kg mackerel, winning a Shimano Stella 5000 HG on a Grappler from NBSFC!

The STARDECK Mackerel 5000 competition continues to strengthen its roots and a special thanks to all competitors who did their part for science by donating samples to our crew, we'll see you in 2026!
